Re: Response-August 16, 2021 Public Records Request

Dear Mr. Martin:

On behalf of the Arizona Department of Health Services (“ADHS”), I am responding to your August 16, 2021 public records request (the “Request”). In your Request, you ask for communicable disease related information, specifically records “describing the isolation of a SARS-CoV-2 virus, directly from a sample taken from a diseased patient, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; liver cancer cells, lung cells from a lung cancer patient).”

In response to your Request, ADHS does not have any records “describing the isolation of a SARS-CoV-2 virus, directly from a sample taken from a diseased patient, where the patient sample was not first combined with any other source of genetic material.” Please note that available de-identified COVID-19 data, including case data, may be reviewed at: <https://www.azdhs.gov/covid19/data/index.php>. You may also wish to check with the Centers for Disease Control and Prevention for information that may be useful to you. See <https://www.cdc.gov/coronavirus/2019-ncov/index.html>.

In addition, even if ADHS had records responsive to your Request, A.R.S. § 36-664(A) states: “[a] person who obtains **communicable disease related information** in the course of providing a **health service** or obtains that information from a health care provider pursuant to an authorization **shall not disclose or be compelled to disclose** that information except as authorized by state or federal law....” (Emphasis added). See also A.R.S. §§ 36-661(5), (14), (21), 36-664(C), 36-665 and 36-666(A)(2) (it is a class 3 misdemeanor to disclose communicable disease related information in violation of A.R.S. Title 36, Chapter 6, Article 4); May 29, 2020 Under Advisement Ruling issued in Maricopa County Superior Court Case No. CV2020-005385; January 29, 2021 Minute Entry issued in Maricopa County Superior Court Case No. CV2020-012030.

Further, A.R.S. § 36-784(C) states: “[a]ny medical information or other information from which a person might be identified that is received by the department or local health authority in the course of an enhanced surveillance advisory is **confidential and is not available to the public.**” (Emphasis added). *See also* A.R.S. §§ 36-136(I)(11),<sup>1</sup> 36-785(C) (information from which a person might be identified that is received by ADHS in the course of an enhanced surveillance advisory is confidential and not available to the public), 36-790(A) (requiring ADHS to maintain the confidentiality of the medical information and personal identifiers received), May 29, 2020 Under Advisement Ruling issued in Maricopa County Superior Court Case No. CV2020-005385; January 29, 2021 Minute Entry issued in Maricopa County Superior Court Case No. CV2020-012030.

Based on the foregoing, ADHS does not have the records you seek, and in the event your Request seeks more than the publicly available COVID-19 data accessible through the aforementioned ADHS webpage, ADHS cannot make those records available to you as a matter of law. Either way, ADHS is unable to fulfill your Request.

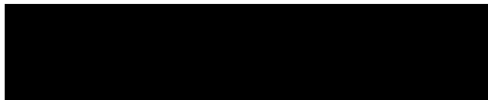

**NOTICE OF DECISION UNDER SECTION 24A  
OF THE FREEDOM OF INFORMATION ACT 1982**

I refer to your request of 11 September 2021 to the Department of Health (the department) seeking access under the *Freedom of Information Act 1982* (Cth) (the FOI Act) to documents related to COVID-19. Your request is in the following terms:

1. All studies and/or reports in the possession, custody or control of The Australian Department of Health describing the purification of any "COVID-19 virus" (aka "SARS-CoV-2", including any alleged "variants" i.e. "B.1.1.7", "B.1.351", "P.1") (for example: via filtration, ultracentrifugation and chromatography), directly from a sample taken from a diseased human where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum)

**Information about COVID-19**

SARS-CoV-2, the virus which causes COVID-19, is real. Multiple scientific studies across the world demonstrate that highly reputable laboratory medicine experts have isolated and sequenced the virus that causes COVID-19, demonstrating that the virus exists, that it exists in variant forms, that it is different from the influenza virus, and that it causes a disease that has resulted in more than 4.8 million deaths worldwide in just over 21 months.

While the department is not the custodian of the scientific studies establishing the existence of SARS-CoV-2, this research has informed the Australian Government's response to the pandemic. You can find those scientific studies in the public domain.

The department is a government agency and does not conduct scientific studies or laboratory testing for the SARS-CoV-2 in a laboratory. Diagnostic assays using reverse transcriptase polymerase chain reaction (RT-PCR) are conducted by testing laboratories throughout Australia. For more information, please see the Public Health Laboratory Network (PHLN) guidance on laboratory testing for

SARS-CoV-2, which is available online:

In Australia, scientists at the Victorian Infectious Diseases Reference Laboratory at The Peter Doherty Institute for Infection and Immunity were the first to isolate SARS-CoV-2 outside of China, winning the 2020 MJA/MDA National Prize for Excellence in Medical Research. This critical information was immediately shared with local and overseas reference laboratories and major North American and European virus culture collections. These peer-reviewed, evidence-based publications provide scientific evidence for the existence of this deadly virus.

All viruses, including SARS-CoV-2, change over time as part of their natural evolution. A change may or may not give the virus a biological advantage. Existing and emerging variants are constantly monitored using genomic surveillance to detect those that pose or may pose an increased risk to human health.

In Australia, whole genome sequencing (WGS) of the SARS-CoV-2 genome is the preferred way to determine the variant and mutation patterns of the virus. Some RT-PCR tests have been designed to detect specific SARS-CoV-2 variants of concern. The performance of these tests is still being established, and they will not identify variants that they have not been designed for.

I would also like to inform you that the department does not have access to all documents created by, received by, or stored by other government entities. You might like to submit a request for access to documents held by a particular Commonwealth, State or Territory agency if you would like access to documents held by that entity.

Attached to this email is an article published in the Daily Telegraph on 13 August 2021 that may be of interest to you.

### **FOI decision**

I am authorised under subsection 23(1) of the FOI Act to make decisions in relation to Freedom of Information requests. I am writing to notify you of my decision in response to your request.

The FOI Act provides a mechanism for individuals to request access to documents held by relevant entities. It is not a mechanism for asking questions or seeking information that the entity does not hold in documents.

Appropriate steps have been taken to find documents you have requested including consultation with relevant departmental officers and searches of departmental file management systems.

I am satisfied, on the basis of the consultation undertaken and the searches conducted, that the department, including the Therapeutic Goods Administration (TGA), does not hold any documents referred to in your request. While the department is not the custodian of scientific studies establishing the existence of SARS-CoV-2 and that of its variants, this research, which is available in the public domain, has informed the Australian Government's response to the pandemic.

As a consequence, relying on section 24A of the FOI Act, I cannot provide access to the documents you requested.

### **FOI review rights**

If you are dissatisfied with my decision, you may apply for a review.

#### Internal review

Under section 54 of the FOI Act, you may apply for internal review of this decision. In accordance with section 54B of the FOI Act, an application for internal review must be made in writing within 30 days after the day you are notified of this decision (or such further period as the department allows). To assist in the internal review process, please provide reasons you consider the review of my decision is necessary.

The internal review will be carried out by another officer of this department within 30 days of receipt of your application.

In accordance with subsection 54S(1) of the FOI Act, an IC review application in relation to a decision covered by subsection 54L(2) (access refusal decisions) must be made in writing within 60 days after the day you are notified of this decision (if you do not request an internal review).

This is a formal request for access to general records, made under the *Municipal Freedom of Information and Protection of Privacy Act*.

**Please note:** this request is very similar to another request that I submitted on May 16, 2021 where I had **specified** purification *via maceration, filtration and use of an ultracentrifuge*. The difference with this new request is that it does **not specify** maceration, filtration and use of an ultracentrifuge; instead it mentions filtration, ultracentrifugation and chromatography by way of an example.

### Application Fee

I will mail the \$5 application fee to the address listed above. **Please do not mail my cheque back to me this time. If you have no records, please recall that your 2 options that are in accordance with MFIPPA are to either transfer the request to another institution or state that Aylmer Police Service has no responsive records.** Also, please note that I already have confirmation from Health Canada, Public Health Agency of Canada, Public Health Ontario, the Ontario Ministry of Health, all 5 of the Canadian institutions that have falsely aka fraudulently claimed to have "isolated the virus", and institutions in over 20 countries, that they have no such records.

Regarding your letter to me dated October 7, 2021 (Subject line: ... **Access Request Number 21-G-2669**):**You stated: "... this is a request for medical information."**

That is incorrect. Laboratory purification of very small things in the size range of alleged viruses has nothing to do with the practice of medicine but rather chemistry. Regardless, purification is an essential (but not sufficient) investigative step that is required in order to know that a "virus" actually exists.

Calgary Police have enforced the so-called "emergency legislation" and thus ought to have such records on hand. (Recall that my request was not limited to records **authored** by Calgary Police.)

**You stated: "we are returning your general access fee..."**

Returning my cheque and refusing to complete my request is not an option that is in accordance with the legislation. Section 12(1) of the **Act** states:

**Contents of response 12(1)***In a response under section 11, the applicant must be told:*

- (a) **whether access to the record or part of it is granted or refused,**

- (c) **if access to the record or to part of it is refused,**
  - (i) **the reasons for the refusal and the provision of this Act on which the refusal is based,**
  - (ii) **the name, title, business address and business telephone number of an officer or employee of the public body who can answer the applicant's questions about the refusal, and**
  - (iii) **that the applicant may ask for a review of that decision by the Commissioner or an adjudicator, as the case may be.**

**I require a clear response that is in accordance with the legislation.****You stated: "we... recommend that you contact Alberta Health Services instead."**

Thank you, however I still require a clear response regarding records that are in the possession/custody/control of Calgary Police.

Please note: I and many others have already submitted requests to the Alberta Ministry of Health and over 100 other health and science institutions globally, over 30 of them in Canada (including the 5 Canadian institutions that had publicly claimed to have "isolated the virus"). Every institution thus far has failed to provide or cite even 1 record of the alleged virus having been purified from even 1 patient sample, by anyone, anywhere on the planet. All of the responses are publically available on my website:

FOIs reveal that health/science institutions around the world (116 and counting!) have no record of SARS-COV-2 isolation/purification, anywhere, ever.

Please advise how you intend to remedy having interfered with my request by mailing the application fee back to me.

Thank you for your e-mail dated October 14, 2021, regarding our returning of your general access fee and your request for information regarding records “describing the purification of the alleged Covid-19 Virus”.

Section 12(1) of the *Freedom of Information and Protection of Privacy Act* references how we are to respond to an access request that we have accepted. As mentioned in your letter, you clarified that this was not a request for medical information but rather “laboratory purification” which has to do with chemistry. The Calgary Police Service does not collect records regarding purification of viruses.

You indicated in your e-mail “*Calgary Police have enforced the so-called “emergency legislation” and thus ought to have such records on hand.*” CPS is a law enforcement organization whose role is to enforce legislation. We do not collect or review information with regards to whether a legislation should or should not be enacted - that is the role of law makers. Once a law is enacted, CPS has a duty to enforce that law. As such, we do not have these types of records within our custody and control.

As per section 6(1) of FOIP, an applicant has a right of access to any record in the custody or control of a public body. Since these records are not in the custody or control of the Calgary Police Service, we have returned your application fee as this is not a request for information that the Calgary Police Service has. It is not the practice of the Calgary Police Service to accept the fee for records that are not in our custody or control. Normally, when a request for records is received that does not pertain to Calgary Police Service records, we would transfer the request under section 15(1) to the appropriate public body. In this case, we could not determine which public body would be most appropriate, which is why we advised contacting Alberta Health Services directly.

As per the letter mailed to you on October 7, 2021, please contact the Office of the Information and Privacy Commissioner to request a review if you are dissatisfied with our response.

Thank you for your access request and accompanying \$5.00 application fee under the *Municipal Freedom of Information and Protection of Privacy Act* (MFIPPA), which I received on September 17, 2021. You are asking for all records describing the isolation of a SARS-COV-2 virus, directly from a sample taken for a diseased patient, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka vero cells; liver cancer cells. You have further indicated that you are not requesting records where isolation of SARS-COV-2 refers to the culturing of something, or the performance of an amplification test (i.e. a PCR test), or the sequencing of something.

The laboratory test results of residents of Halton Region that have tested positive for SARS-COV-2 have been provided to our Health Department by Public Health Ontario (who is responsible for COVID-19 testing). Although these records describe the testing method used for the SARS-COV-2 virus, according to our Health Department's Director of Infectious Diseases Control all records of positive COVID-19 test results received from Public Health Ontario indicate that patient samples submitted for COVID-19 testing were analysed by means of a PCR test. As such, we have not located any records that are responsive to your request.

Since the testing for COVID-19 is completed by Public Health Ontario, Laboratory Services, you may wish to review the details of PCR testing for COVID-19 on their website at the following web address: <https://www.publichealthontario.ca/en/laboratory-services/test-information-index/covid-19>.

This is a formal request for access to general records, made under the *Municipal Freedom of Information and Protection of Privacy Act* due to enforcement by members of Hamilton Police Service of unlawful, fraud-based "COVID-19" restrictions.

Please note:

1. Your website states: *"Applicants must also include a photocopy of two pieces of government-issued photo identification with your request."*

I have made many FOI requests under MFIPPA in recent years, including in recent weeks and months, and have never been advised that I must submit copies of any identification whatsoever. Nor am I aware of any provision in MFIPPA that authorizes an institution to require submission of copies of identification.

Therefore, I will only provide you with copies of my identification if you cite for me a new provision in the Municipal Freedom of Information and Protection of Privacy Act that authorizes you to require such.

2. Your website also states that *"Requests must be made in writing by completing the Municipal Freedom of Information and Protection of Privacy Act form and mailing it... requests will not be accepted or fulfilled online"*.

Section 17 (1) of the Act requires a person seeking access to a record to make their request in writing, but not to submit it through the mail.

I am unaware of any provision in MFIPPA that authorizes an institution to require applicants to submit their requests specifically through the mail, and I have successfully submitted literally dozens of MFIPPA requests via email over the years, and in recent months.

Therefore, I will submit my application through the mail, if you cite for me the new provision in the Municipal Freedom of Information and Protection of Privacy Act that authorizes you to require me to.

3. Further, I notice that Hamilton Police Service's Access/Correction Request form (attached) asks for personal information that is inappropriate and unnecessary for a general records request (gender, date of birth). On page 2, the form specifically asks *"Did you... Fill in your date of birth?"*

I will not be providing you my gender or my date of birth, and am curious as to why Hamilton Police Service claims to require such information from someone requesting access to records.

4. Regarding this statement of page 2 of your form: *"Once the application is received, you will hear from the F.O.I. Branch within 30 days or up to 90 days in circumstances where we are required to contact other individuals."*

Sections 19 and 20 of the Act require an institution to make contact within 30 days.

**Description of Requested Records:**

Your request has resulted in a "No Records Exist", firstly as this would be a Public Health Agency of Canada request and also because of the way that you have formulated the request. The isolation of the virus is not completed without the use of another medium, therefore we have no records that would show this process taking place. It is important to understand the following: The gold standard assay used to determine the presence of intact virus in patient samples is viral isolation in cell culture. With this assay, if virus is present in the patient sample, it will multiply and produce visible cytopathic effects, which means that infected cells demonstrate visible changes. Additionally, the detection of an increase in the genetic viral material by PCR further confirms that intact virus is present in the patient sample, since increasing viral genetic material necessitates replication of the viral within the cell culture. This technique was successfully used to confirm that intact SARS-COV-2 was present in Canadian patient samples. In the case of SARS-COV-2 isolation, Vero cells combined with minimal

essential medium (MEM) were used because they are essential to support viral replication and cell growth. This combination supports the growth of other coronavirus types and was successful in the case of SARS-CoV-2 as well.

- Vortex

- Solution de PBS - influenza pH 7,5

## IX. ÉQUIPEMENT (entretien et vérification)

## X. CONTRÔLE DE LA QUALITÉ

Chaque analyse doit inclure un contrôle interne négatif – vial de cellules non infecté.  
Un contrôle positif doit être inclus à l'utilisation d'un nouveau lot de cellules – portion aliquote adéquate de contrôle positif interne.

## XI. PRÉCAUTIONS SPÉCIALES

Toute manipulation avec des cultures cellulaire infectées avec des échantillons de patients potentiellement positifs pour le virus SARS CoV-2 doit être effectuée sous une ESB en **NC3**.

## XII. EXPOSÉ DE LA PROCÉDURE

### 1) Inoculation en vial :

#### *Préparation des vials en NC2*

- Laver les cultures de cellules avec du PBS pH 7,5 stérile préchauffé à 36 - 38°C (2,0 mL pour un vial).
- Ajouter 2,0 ml de milieu de maintien préchauffé à 36 - 38°C.
- À cette étape, ajouter 100µL de milieu dans le témoin négatif.
- Vortexer les échantillons et les placer dans une mallette pour le transfert en NC3.

#### *Transférer les portoirs de vials et échantillons en **NC3** pour faire l'inoculation*

- Ajouter 100µL de l'échantillon à analyser (au besoin incliner les tubes).
- Prendre soin de dévisser légèrement les tubes.
- Incuber le portoir de vials à 36 – 38°C avec 4,0-6,0% de CO<sub>2</sub>.

Si possible, effectuer une lecture journalière des cultures pendant 10 jours et inscrire les résultats de l'observation du feuillet cellulaire dans le registre qui sera numérisé et envoyé à votre poste de travail.

Au besoin, si le milieu devient acide (jaunâtre) ou si le feuillet du témoin négatif dégénère, au jour 5 jours ± 2 retirer environ 1,0 mL de milieu pour le remplacer par du milieu frais.

**Note : Reprendre l'inoculation du spécimen s'il y a présence de contamination.**

### 2) Inoculation avec culture cellulaire en flacon (F25)

- Diluer l'échantillon au besoin avec du milieu de maintien DMEM. (ex.100 µL culture + 900µL DMEM)
- Laver les cultures de cellules avec 5,0 mL de PBS pH 7,5 stérile.
- Ajouter environ 1,0 mL d'échantillon (possiblement dilué) à analyser.
- Incuber à 36 - 38°C pour 60 minutes à 4,0 - 6,0% de CO<sub>2</sub> en agitant à toutes les 20 minutes.
- Ajouter le milieu de maintien (ex: 9,0 mL pour les flacons de culture de 25 cm<sup>2</sup>).
- Incuber un flacon de cellules non infectées qui servira comme contrôle négatif.
- Incuber à 36 - 38°C à 4,0 à 6,0% de CO<sub>2</sub> en dévissant légèrement les flacons de culture.

Si possible, effectuer une lecture à tous les jours pendant 10 jours et inscrire ces résultats dans le registre.

Au besoin, au jour 5 ± 2, faire un changement de milieu de maintien si le milieu devient acide ou le feuillet du témoin négatif dégénère. Retirer 7,0 ml de milieu et en ajouter l'équivalent.

**Note : Reprendre l'inoculation du spécimen s'il y a présence de contamination.**

Au besoin, effectuer le test PCR avec les spécimens analysés



### XIII. RÉSULTATS ET INTERPRÉTATIONS

Un résultat positif est exprimé par un ECP. Généralement l'échelle utilisée est de 1+ à 4+ (1+ étant un ECP très faible). Quand l'ECP est de 3 à 4+, il reste moins de 25% de cellules encore adhérentes au vial ou flacon et l'échantillon est considéré positif. Récolter le surnageant et le distribuer dans des tubes Sarstedt ou cryotubes à raison de 1,0 ml/tube qui seront entreposés dans le congélateur au NC3 à -70°C.

Bien identifier les tubes en inscrivant le numéro d'identification du spécimen, et autres informations possiblement pertinents - la date de récolte, la journée post-infection.

S'assurer de mettre à jour le registre d'inventaire de placement des échantillons dans le congélateur tombeau à -70°C disponible dans le cartable au local 1.253 et aussi dans S : partage/virologie/congélateur NC3 (-70) #3124.

Noter qu'un spécimen est négatif après 10 jours si aucun ECP n'est observé en culture. Le spécimen est alors jeté ou conservé si il devient pertinent d'effectuer d'autres analyses sur le surnageant.

### XIV. LIMITES DE LA MÉTHODE

Un résultat négatif n'exclut pas la présence de virus dans le spécimen clinique.

Un effet cytopathique (ECP) n'est pas nécessairement relié à une propagation du virus CoV-2, il peut être causé par la présence d'un autre virus ou être dû à un effet cytotoxique.

## **I. PREAMBLE**

This is a new document created as a guide for inoculation in culture of SARS-CoV 2 detected by PCR in clinical samples, or from infected cell lines in order to increase the number of viral particles.

## **II. OBJECT**

This document aims to describe the technique used to inoculate a cell line from respiratory specimens taken or from infected cell lines in order to amplify the number of viral particles.

## **III. GOALS**

This technique makes it possible to demonstrate the contagious nature of SARS particles CoV-2 by the observation of a cytopathic effect.

## **IV. SCOPE**

This document is intended for personnel in the Serodiagnosis and Virology sector who have received adequate and documented CL3 training, as well as training in cell culture.

This procedure applies to specimens received for the diagnosis of virus infection respiratory SARS-CoV-2.

## **V. DEFINITIONS OF TERMS**

CPE: Cytopathic effect

## **VI. PRINCIPLE**

Specimen inoculation allows when viruses are present to bind them to the cell membrane.

Viruses once adsorbed enter the cell to multiply. This viral multiplication usually results in CPE in the VeroE6 cell line when several rounds of replication destroy infected cells.

## VII. SPECIMEN

Specimens are respiratory in nature or may be obtained from cell cultures.

## VIII. MATERIAL REQUIRED

Material:

- 15 ml or 50 ml centrifuge tube
- Serological pipettes of 1, 5 and 10 ml
- Vial for cell culture (# 5900239 or equivalent)
- Bottle (F25)
- Sterile transfer pipettes
- Incubator (36 - 38 ° C) with 5% CO<sub>2</sub>
- Micropipette from 10 to 100 µL and sterile tips
- Micro sterile tubes 2,0ml Sarstedt #cat 72.693.005 or equivalent
- Vortex

Reagents:

- PBS solution - influenza pH 7.5
- Maintenance medium used for inoculation of specimens (DMEM medium, glutamine, HEPES, GVF 100X - gentamycin, vancomycin, fungizone - and fetal bovine serum. the

See register RE-VR-003 and modify it with the addition of GVF 100X instead of

gentamicin

- VeroE6 cells in culture

#### **IX. EQUIPMENT (maintenance and checking)**

The devices used are checked and maintained according to their respective procedures.

#### **X. QUALITY CONTROL**

Each analysis should include a negative internal control - vial of uninfected cells.

A positive control should be included when using a new batch of cells - aliquot adequate internal positive control.

#### **XI. SPECIAL PRECAUTIONS**

Any manipulation with cell cultures infected with patient samples potentially positive for SARS CoV-2 virus should be performed under a BSE in CL3.

#### **XII. STATEMENT OF THE PROCEDURE**

1) Vial inoculation:

Preparation of vials in NC2

- Wash cell cultures with sterile PBS pH 7.5 preheated to 36 - 38 ° C (2.0 mL for one vial).
- Add 2.0 ml of holding medium preheated to 36 - 38 ° C.
- At this step, add 100µL of medium to the negative control.
- Vortex the samples and place them in a case for transfer to CL3.

Transfer the vial and sample racks to CL3 to inoculate

- Add 100µL of the sample to be analyzed (if necessary tilt the tubes).
- Take care to slightly unscrew the tubes.
- Incubate the vial rack at 36 - 38 ° C with 4.0-6.0% CO<sub>2</sub>.

If possible, take a daily culture reading for 10 days and record the results of the observation of the cell sheet in the register which will be digitized and sent to your workstation.

If necessary, if the medium becomes acidic (yellowish) or if the negative control sheet degenerates, on day 5 ± 2 days remove approximately 1.0 mL of medium to replace it with cool medium.

**Note: Resume inoculation of the specimen if contamination is present.**

## 2) Inoculation with cell culture in a flask (F25)

- Dilute the sample as needed with DMEM maintenance medium. (e.g. 100 µL culture + 900µL DMEM)
- Wash cell cultures with 5.0 mL sterile PBS pH 7.5.
- Add approximately 1.0 mL of the sample (possibly diluted) to be analyzed.
- Incubate at 36 - 38 ° C for 60 minutes at 4.0 - 6.0% CO<sub>2</sub>, shaking every 20 minutes.
- Add the maintenance medium (eg 9.0 mL for the 25 cm<sup>2</sup> culture flasks).
- Incubate a vial of uninfected cells to serve as a negative control.
- Incubate at 36 - 38 ° C at 4.0 to 6.0% CO<sub>2</sub> by slightly unscrewing the vials of culture.



If possible, take a reading every day for 10 days and record these results in the registry.

If necessary, on day  $5 \pm 2$ , change the maintenance medium if the medium becomes acid or the negative control sheet degenerates. Remove 7.0 ml of medium and add more the equivalent.

**Note: Resume inoculation of the specimen if contamination is present.**

If necessary, perform the PCR test with the analyzed specimens

### **XIII. RESULTS AND INTERPRETATIONS**

A positive result is expressed by an CPE. Generally the scale used is 1+ to 4+ (1+ being a very low ECP). When the CPE is 3 to 4+, there are still less than 25% of cells adhered to the vial or vial and the sample is considered positive. Collect the supernatant and distribute in Sarstedt tubes or cryotubes at a rate of 1.0 ml / tube which will be stored in the freezer at NC3 at  $-70^{\circ}\text{C}$ .

Identify the tubes by entering the identification number of the specimen, and others possibly relevant information - harvest date, post-infection day.

Make sure to update the sample placement inventory register in the tomb freezer at  $-70^{\circ}\text{C}$  available in the binder in room 1.253 and also in S:  
sharing / virology / freezer NC3 ( $-70$ ) # 3124.

Note that a specimen is negative after 10 days if no ECP is observed in culture. The specimen is then discarded or kept if it becomes relevant to carry out further analyzes on the supernatant.

#### **XIV. LIMITATIONS OF THE METHOD**

A negative result does not exclude the presence of virus in the clinical specimen.

A cytopathic effect (CPE) is not necessarily linked to the spread of the CoV-2 virus, it may be caused by the presence of another virus or be due to a cytotoxic effect.

#### **XV. DATA RECORDING**

This is a formal request for access to general records, made under Ontario's Freedom of Information and Protection of Privacy Act, due to unlawful activity by members of the Ministry and the Ontario Provincial Police.

Please note that according to the website of the [Ontario Provincial Police](#) (OPP), the OPP is a division of the Ministry of the Solicitor General. However the Access/Correction Request [form](#) that is posted on the OPP's Freedom of Information [webpage](#) is for requests directed to the Ministry of Community Safety and Correctional Services, which is confusing for the public.

**Description of Requested Records:**

All studies and/or reports in the possession, custody or control of the Ontario Provincial Police or the Ministry of the Solicitor General describing the **purification** of the alleged "**COVID-19 virus**" (aka "SARS-COV-2", including any alleged "variants") directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of **genetic/biological** material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

As for part two of your question, you are correct in your interpretation of what makes a request. The first part of section 24(1)(a) of the Act states; the request must be in writing. Part (c) of this section is also very clear that payment has to be paid at the time of making the request. I have copied the relevant section of the Act for your review.

24 (1) A person seeking access to a record shall,

(a) make a request in writing to the institution that the person believes has custody or control of the record, and specify that the request is being made under this Act;

(b) provide sufficient detail to enable an experienced employee of the institution, upon a reasonable effort, to identify the record; and

(c) at the time of making the request, pay the fee prescribed by the regulations for that purpose.

Thank you, however I am not concerned with anyone's "position" or "direction", or when the legislation was written, or in wasting time with the IPC right now. I am only interested in what the Ministry is and is not **authorized** to do, and what the Ministry is **required** to do.

You have acknowledged that you / the Ministry are **not** authorized by the legislation to refuse a request simply because it is submitted via email.

Re section 24 (1) (c), it is clearly **not** intended to require payment at the **exact same moment** that the request is submitted. Such a requirement would be bizarre, not in the public interest, and contrary to the purposes and intent of the legislation. Literally thousands of successfully completed FIPPA requests in recent months/years (including many of my own) would never have been completed.

The OPP's FOI [webpage](http://www.mcscs.jus.gov.on.ca/english/about_min/foi/foi.html) cites this Ministry webpage: [http://www.mcscs.jus.gov.on.ca/english/about\\_min/foi/foi.html](http://www.mcscs.jus.gov.on.ca/english/about_min/foi/foi.html) which states:

*You will need to pay that fee when you submit your request. You can pay by **cheque, money order, credit card (Visa or Master Card) or Visa Debit/Mastercard Debit (online only)**... After you've filled out the form, you can send it in **by mail or by fax**.*

So the OPP and the Ministry are quite willing to accept credit card numbers online, via fax, or by mail, and cheques and money orders, and presumably cash, by mail, and to use email for FOI communications (hence the [foi.solgen@ontario.ca](mailto:foi.solgen@ontario.ca) email address), and to repeatedly transmit messages that contain my home address via email as you and your colleagues have already done.

**The details of my request have already been submitted via email and my cheque is in the mail. Upon arrival of my cheque, the request will be complete and the Ministry will be obligated to process it.**

I will **not** be providing my middle name or date of birth despite Renee's strange claim that "*We'll need your full name (including middle name) and date of birth (please enter in the description of records).*"

In addition to a response that is in accordance with FIPPA, I require an explanation as to why requesters such as myself are being directed to provide information that is **not** necessary and the Ministry is **not** authorized to demand.

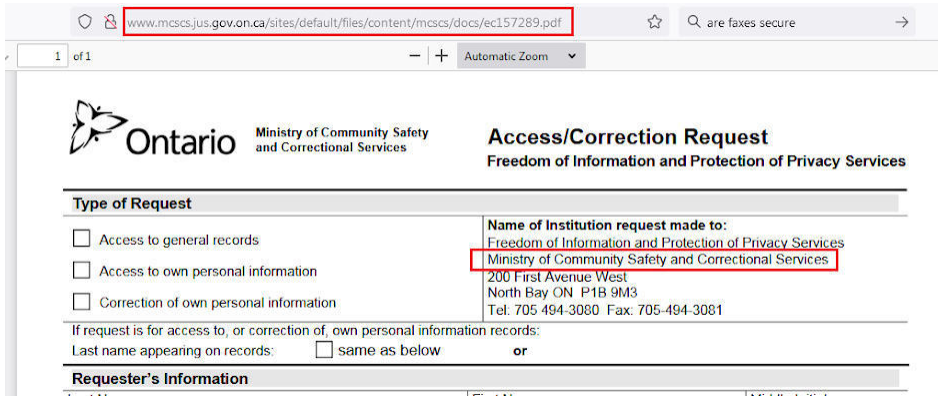

- fabricated a "genome" by editing/assembling/aligning sequences detected in the total RNA from a patient sample or from a cell culture or from any unpurified substance, and/or

Viruses are not independent living entities. They require a host cell substrate to replicate.



PHE's microbiology teams use the term "isolation" to mean culture in the laboratory. It is used sometimes interchangeably to mean isolation from a patient or clinical material – but usually implies that the organism has been grown in culture. An organism is identified by looking for its unique genetic material in a clinical sample and further identification is refined and confirmed by whole genome sequencing.

The Virus Reference Laboratory at PHE, Colindale, London has grown the virus, SARS-CoV-2. The virus culture method has been published in the following peer-reviewed paper: <https://www.eurosurveillance.org/content/10.2807/1560-7917.ES.2020.25.32.2001483>

Several strains of the SARS-CoV-2 virus has been deposited to the European Virus Archive by PHE.

PHE's culture work on other SARS-CoV-2 variants is in progress and has not been published in any peer-reviewed papers at present.
